Fairfield County Auditor Announces 2022 Weights and Measures Excellence Awards

Lancaster, Ohio – The Fairfield County Auditor's Office is pleased to announce the first recipients of the annual Weights and Measures Excellence Awards. Five businesses throughout Fairfield County were recognized for their exemplary customer service, dedication to fairness in the marketplace, and excellent accuracy with Weights & Measures.

This year's Excellence Award winners are the Berry Family Farm in Pleasantville, Candy Cottage in Lancaster, Mid-State Wool Growers in Canal Winchester, La Dolce Nola in Pickerington, and Rushcreek Feed & Supply in Bremen. These businesses were chosen by Patrick Brighton and Carter Corcoran, Weights & Measures Inspectors, for best meeting the three criteria of exemplary customer service, dedication to fairness in the marketplace, and excellence in accuracy. The Weights & Measures department inspects a variety of scales to ensure customers are getting what they are paying for and to ensure businesses are properly compensated for their products and servies. Items inspected include food scales, livestock scales, and gas pump meters. Upon request, the inspectors also test scales that constituents believe to be incorrect.

Dr. Carri Brown, County Auditor, stated, "The Weights and Measures department protects Fairfield County businesses and consumers. A lot of people do not know that the inspectors test devices ranging from fuel meters and retail store scanners to vehicle and livestock scales."

From the start, they have actively reached out to W&M multiple times to help them make sure they are doing the process correctly. Their top priority is to make sure their customers are getting the correct amount of the highest quality product. They are always friendly and welcoming every time an inspector has come to their home to inspect their scale.

Rushcreek Feed & Supply 103 South Broad St, Bremen

This is an important staple business in the southern part of Fairfield County with their entire business relying solely on their scales. They take that mindset seriously by regularly bringing in their service company to re-check their devices so all their sales are accurate. Even when they are busy, they will do their best to accommodate the inspector, or they will communicate with them if Weights & Measures is unable to test. In the past, when an inspector has requested a replacement vehicle scale (which is very expensive), they did not question the request, and were quick to get the process started.
